
In view of the Fax Message received from the Chief Secretary to the Government of Himachal Pradesh vide No.GAD-A(A)9-1/2001 dated 27 December, 2024, the state mourning will be observed throughout the state for seven days from 26.12.2024 to 01.01.2025 (both days inclusive). The State Government has further decided that all offices under the control of Himachal Pradesh Government including Boards and Corporations and all Educational Institutions will remain closed for two days i.e. on 27<sup>th</sup> & 28<sup>th</sup> December, 2024 as a mark of respect to the departed leader **Dr Manmohan Singh, Former Prime Minister of India**. Accordingly, this University will also remain closed on 27<sup>th</sup> & 28<sup>th</sup> December, 2024 as notified by the Registrar vide notification No. UHF/Regr/GA/5-24/2024/-34253-80 dated 27.12.2024.
