The bid shall be opened by the committee on same day i.e. on 25.07.2025 at 02:30 PM in presence of the bidder.

The interested bidders may inspect the Apple crop by visiting the apple orchard on any working day with the prior permission of the undersigned. The interested bidders participating for the auction should have to deposit an earnest money amounting to Rs. 20000/- (Rs. Twenty Thousand) only, which will be refundable to the unsuccessful bidders. The successful bidder will have to deposit the half of the amount on the same day and the half before harvesting of apple fruit crop.
