

The bidder must write his name and address on the sealed bid and the word "Quotation" on the top of sealed envelope. The bid shall be opened by the committee on same day i.e. on 24.09.2025 at 02:30 PM in presence of the bidder.

The interested bidders may inspect the Persimmon crop by visiting the persimmon block on any working day with the prior permission of the undersigned.
