## **Notification**

On the recommendations of the Director Extension Education, the Hon'ble Vice-Chancellor, Dr. Yashwant Singh Parmar, University of Horticulture & Forestry, Nauni-Solan has approved to fix the rates of honorarium/remuneration to be paid to faculty members, external experts, and other staff involved in delivering lectures and providing secretarial assistance during sponsored training programs being organized in the

University as under:

<i>1.</i>	Faculty of Dr. YSP, UHF, Nauni for delivering lectures (Maximum honorarium for 02 (two) lectures only)	₹ 700/- per lecture
2.	Experts from the outside of Dr. YSP, UHF, Nauni (Solan) (Maximum three lectures per expert)	₹ 1,000/- per lecture
3.	(A) * Convener/*Coordinator of Trainings: (i) One day activity (ii) Two to Four days activity (iii) Five & above days activity	₹ 750/- ₹ 1,000/- ₹ 1,500/-
	(B)* Co-convener/*Coordinator: (iii) Two to Four days activity (iv) Five & above days activity	₹ 700/- ₹ 1,000/-
4	Secretarial Assistance	₹ 1,000/- each activity ( @ ₹ 500/- for two officers/officials)

(\*) Important Note

(i) All the Conveners/Co-conveners/Coordinators & Coordinators shall not claim honorarium for delivering lectures in his/her own training.

(ii) However, if funding agency approves honorarium higher or lesser than the approved amount, the same will be considered for disbursement.

These rates will come into effect from the date of issuance of the notification and will be applicable only to the sponsored training programs to be conducted in the University.

This has with the prior approval of the Board of Management vide item No. 16 of the proceedings in its 115<sup>th</sup> meeting held on 27<sup>th</sup> July, 2023 notified vide Notification of even No. 7593-7633 dated 26/08/2023.
