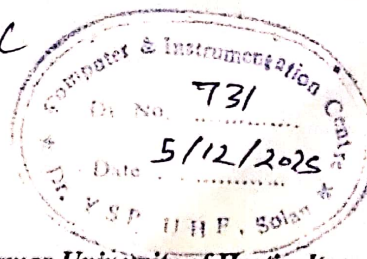

**Subject:** Introduction of Group Personal Accident Insurance Scheme for Regular, Adhoc, Part-Time, Contractual and Daily Waged Employees of the University.

Sir/Madam,

The Principal Secretary (Finance) to the Government of Himachal Pradesh, Shimla vide Notification No. Fin(IF)(F)9-5/2012-I dated 17<sup>th</sup> November, 2025 has renewed the Group Personal Accident Insurance Scheme for Regular, Adhoc, Part-Time, Contractual and Daily Waged Employees on compulsory basis for a period of one year with effect from 18-11-2025 to 17-11-2026 with the premium of ₹ 200/- (Rupees two hundred) per annum per employees for a sum assured of ₹ 5.00 lakh [Rupees five lakh].

It is, therefore, requested that the amount of premium in respect of Regular, Adhoc, Part-Time, Contractual and Daily Waged Employees appointed/engaged in the Departments/Offices/Out Stations shall be collected personally by the DDO concerned and the same will be remitted along with category wise list to the office of the undersigned latest by 15<sup>th</sup> December, 2025. The amount of premium of regular employees may be deducted from the salary/wages bill of November, 2025 payable in December, 2025.

It may also be noted that the DDO concerned will be responsible to get the policy renewed well in time. The scheme is also applicable to all the Out-Stations and KVKs.

The matter being concerning coverage of risks, as such, this may kindly be given your personal attention so that there is no delay in furnishing the information and remission of amount of premium.
